2. All the participating teams must reach at Shiv Chhatrapati Krida Sankul, Mahalunge, Balewadi, Pune on dt. 28<sup>th</sup> May, 2024 on Tuesday at 2.00 pm positively.

Accommodation will be provided for Kabaddi Sports 12 players and two officials (Manager & Coach) total 14 Sports Persons and Table Tennis Sports 04 players and 2 Official (Manager & Coach) total 06 Sports Persons for Wrestling Sports 10 players and two officials (Manager & Coach) total 12 Sports Persons on sharing basis. 6. The tournament will be conducted as per the latest rules of the National Style Kabaddi / Table Tennis/Wrestling Tournament & guidelines of the AIESCB for such Inter Board/Corporation/Company Tournament. **The Kabaddi and Wrestling matches will be conducted on Mat.**

All the members of the participating teams should bring their Identity cards issued by their Board/Corporation as well as the Identity cards if issued by AIESCB and certified by the concerned State Electricity Board/Corporation/Company, failing which they will not be allowed to participate in the tournament.
8. Only regular employees are allowed to take participate in the above said tournament.
9. Protest, if any shall be lodged to the Jury of Appeal on the spot along with Protest fees of Rs. 1,500/- which will be forfeited in case of protest being over ruled.
10. No request for postponement or change in the order of matches will be entertained.
11. All rights are reserved by the Organizing Committee for any addition, alteration whatsoever in the programme and for taking necessary decision regarding dispute etc. if any.
12. The participating teams will be received by our Reception Committee Members at Pune Railway Station/ Pune Airport, Pune on receipt of the prior intimation.
